

Participation Fee

The payment of the participation fees is one of the requirements for qualification in the Eleventh Bidding Round. The fees may be paid by sectors or groups of sectors, exclusively as detailed in the table below. Only bids for the blocks located in the sectors for which the participation fees were paid may be submitted.

The payment of the participation fee should be made preferably by means of bank slip available in the link beside. Another alternative for the payment of the participation fee is a bank transfer. After the transfer, the proof and the reference number of the deposit should be sent by fax to (+ 5521) 2112-8539.

The payments in foreign currency can only be made by bank transfer. The equivalent amount in US dollars will be converted to real by the official purchase exchange rate of ([BACEN - Ptax. compra](#)) of the business day immediately preceding the payment, published by the Central Bank, proviso that any financial intermediation fee on the operation transfer, which is charged abroad or in Brazil, is under the responsibility of the company. The SWIFT CODE to be used for such transfer operations is: BRASBRJRJO001223490003330087

The company which pays participation fee for sectors or groups of sectors may pay participation fees relating to other sectors later. It will not be admitted in any hypothesis, the payment of participation fees for individual blocks in each sector or for groups of sectors different from those listed in the table below.

The payment of the Participation Fee is compulsory and individual to each company, even if they submit bids through consortium.

Once the payment has been made and the form provided in Annex II of the Notice Bidding is filled out and the requirements for the expression of interest are met, the data packets and information may be downloaded.
